THE WITNESS OF GOD AGAINST THOSE WHO TRIED TO SERVE GOD AND MONEY

NO MAN CAN SERVE TWO MASTERS

1. Using religion for gain

Balaam was a prophet during the early days of the nation of Israel. He had a special power. Those whom he cursed were cursed, and those whom he blessed were blessed. The king of Moab hired Balaam to curse Israel; but God warned Balaam not to curse His people, so he blessed them instead. This angered the king of Moab. Balaam appeased the king and collected his money by teaching the king how to morally corrupt the people whom he could not curse. Later, Balaam lost his money and his life when Israel conquered Moab. (See Numbers 22-24; Jude 11; Revelation 2:14.)





2. Compromising with evil

Lot was the nephew of Abraham. He went with Abraham to the land of Canaan, where his flocks and herds increased so much that there was not enough land for his flocks and Abraham's flocks together. Lot separated from Abraham and chose to live near Sodom, an area that was very fertile. Lot's business dealings caused him to compromise in his choice of associates. He tried to be an example to them, but ultimately he lost all of his possessions and most of his family. (See Genesis 12-14, 19.)

3. Mixing faith and self-effort

Jacob was assured by God that he would be blessed, but he felt that he had to help God work out the blessing. He talked his brother out of the birthright, stole his brother's blessing, and cleverly worked to get his father- inlaw's flocks. God brought Jacob to a crisis when his brother Esau came with four hundred men to get revenge for being cheated. Jacob first made restitution and then spent a night wrestling with God. Through that experience he demonstrated a new trust in God, but the seeds of destruction took a heavy toll with his wife and children. (See Genesis 27-34.)

4. Yielding to covetousness

Achan had fought in Joshua's army and had helped to conquer Jericho. He knew of God's promise to give victory and certain spoils of the land to Joshua and his army. In his service for God, however, Achan was exposed to the corrupt things of the enemy. Rather than treating them with Godly contempt, he determined how they would benefit his life; and then he took the forbidden treasures in violation of God's clear command, ... Keep yourselves from the accursed thing, lest ye make yourselves accursed..." (Joshua 6:18). God judged Achan by having him and his entire family stoned to death (See Joshua 7.)

5. Commercializing religion

Gideon was used of God to conquer the Midianites and to free Israel from their oppression The men of Israel asked Gideon to be their king. He refused this honor but requested instead that he be given all of the golden earrings of the enemy. From these earrings he made a golden ephod, a richly-embroidered outer vestment worn by Jewish priests. This ephod became a national tourist attraction; and although it was used for religious worship, it caused "... all Israel [to go]... a whoring after it. ..." (Judges 8:27). Gideon had many wives and seventy sons. After he died, God judged his family through the son of a concubine. This son killed sixty- nine of his half-brothers and seized the kingship which his father had refused. (See Judges 8:24—9:6.)

6. Cashing in on another's ministry

Gehazi was the servant of the prophet Elisha When Naaman, the captain of the Syrian army, came to Elisha to be cured of leprosy, Elisha instructed Naaman through Gehazi. Naaman was miraculously healed of his leprosy, and he wanted to give Elisha a valuable reward. Gehazi listened as Elisha clearly refused it After Naaman left, Gehazi ran after him and, through deception, got some of the reward for himself He was sharply rebuked by Elisha, and the leprosy of Naaman came upon Gehazi (See II Kings 5.)

7. Trying to worship Christ and money

The rich young ruler possessed more than riches. He had character qualities that were outstanding. He showed diligence in coming to Jesus, he demonstrated honor to Jesus, he had a teachable spirit, and he was morally upright from his youth Jesus detected only one major flaw in this young man—he loved money. Jesus instructed him to sell all that he had, give it to the poor, and then follow Him. Upon hearing this, the rich young ruler walked away sorrowfully, for he had great riches. Jesus used this incident to explain how difficult it is for a rich man to enter into the kingdom of heaven. (See Luke 18:18-30.)

8. Selling inside information

Judas was the most trusted of the disciples. He was the only one among the disciples to hold an office. Perhaps he was appointed treasurer because his interest in money was obvious. He evaluated events on the basis of monetary gain for the treasury and for himself. Consequently, he totally missed the message and significance of Mary's anointing of Jesus' feet. He determined that the ointment which she used could have been sold for 300 pence and given to the poor. It is possible that the information he sold to the religious leaders was designed to enrich his pockets while giving Christ another opportunity to escape death. When he saw that he had betrayed innocent blood, Judas returned the money and hanged himself. (See Matthew 26-27.)

9. Purchasing public praise

Ananias and Sapphira were involved in the social concerns of the early Church. When Barnabas sold his property and gave the money to the Church leaders, Ananias and Sapphira saw the admiration and encouragement that he received. They decided to follow Barnabas' example, but they secretly agreed between themselves to keep back part of the money. In this way they planned on getting public recognition while still maintaining private resources. However, their deception failed to elude the spiritual alertness of Peter. When they lied about the amount of the sale, Peter rebuked them. Immediately after being rebuked by Peter, both Ananias and Sapphira fell dead at his feet. (See Acts 5.)

10. Trying to buy spirituality

Simon was a converted sorcerer. Before his salvation he had been a very powerful person. He had kept the people spellbound with his magic and experienced their continual admiration. When Simon saw Peter transmitting the power of the Holy Spirit by the laying on of hands, he immediately recognized this as being more effective than any of his magic. He visualized the personal gain and admiration which he could have with this power, so he offered Peter money to buy it. Peter sharply rebuked Simon for his carnal approach to spiritual ministry. In his rebuke, Peter exposed Simon's root problems, saying that Simon was in the gall of bitterness and bound with his own iniquity. (See Acts 8:9-24.)

HOW TO SERVE GOD RATHER THAN MONEY

Most Christians, if asked, would claim that they are serving God. They would deny that they have a greater love of money than of God. However, God knows our hearts. He searches out our motives. He is aware of how many of the following steps we have actually taken.

1.

NAME THE THINGS THAT YOU LOVE THE MOST

...Take now thy son, thine only son Isaac, whom thou lovest..." (Genesis22:2).

God will always start with the things that we love the most. He will direct us to name the people or possessions which have captured our affections.

Unless the objects of our strongest love are dedicated to Him, they will become objects of our worship and sources of future sorrow. In the end, we will lose the very things that we refused to give to God.

Present them completely to the Lord

"... Offer him there for a burnt-offering upon one of the mountains which I will tell thee of" (Genesis 22:2).

God's way of doing business involves a specific time and place. He wants us to make definite decisions that we will remember.

Just as Abraham built his altar, we can also get alone with the Lord and "build our altar."

Abraham was confident that the God who told him to offer his only son was also able to raise him up again. We can be sure that whatever we give to God He can protect and bless and restore. "... I know whom I have believed, and am persuaded that he is able to keep that which I have committed unto him against that day" (II Timothy 1:12).

By giving our most cherished objects of affection to the Lord, we are saying: "From this moment on these things belong to You. I give them to You. I have no more rights to them or claim on them."

• Die to them in your human emotions

"And Abraham stretched forth his hand, and took the knife to slay his son" (Genesis 22:10).

The action of dedicating our most cherished possessions to the Lord is not complete until we die to them in our human emotions.

This means that we *thank God ahead of time* for whatever He allows to happen to the things that we gave to Him.

Be prepared to thank God if He allows the things that you gave to Him to be taken from you; and be prepared to thank God if they are entrusted back to your care. Abraham never could have lifted the knife over his son if he had not first "died to him" in his human emotions. Without this emotional break, the offering is only a meaningless ritual.

Realize that God will test your sincerity with whatever you give to Him.

EXPECT GOD TO SHOW HIS SUPER-NATURAL POWER THROUGH THAT WHICH YOU GIVE TO HIM

...Lay not thine hand upon the lad.... Because thou... hast not withheld thy son ... I will bless thee ..." (Genesis 22:12, 16-17).

Abraham learned that the real sacrifice takes place in the heart, not in the act of sacrifice itself.

Abraham also illustrates that once we emotionally let go of our most treasured possessions, God will be able to show His miraculous power through them. They will become the basis of our service to Ged and the means through which He works.

Abraham gave his son to God, and God made of him a great nation. Moses gave his rod to God, and God worked through it to lead the nation of Israel out of bondage.

- Give your marriage to God, and He will give you love that surpasses human understanding. (See Ephesians 3:19.)
- Give your family to God, and He will raise up the foundations of many Godly generations. (See Isaiah 61:4.)
- Give your home and possessions to God, and you .. shall receive an hundredfold now in this time ... and in the world to come eternal life" (Mark 10:30).
- Give your friendships to God, and He will allow you to experience true fellowship. (See I John 1:7.)
- Give your reputation to God, and He will lead you to make right decisions in order to protect His reputation. (See Psalm 23:3.)

THE PRECISE STEPS WHICH A FATHER TOOK IN TRANSFERRING OWNERSHIP TO GOD

I PICTURED MYSELF KNEELING BEFORE GOD'S ALTAR

"I knew that I had failed in managing the money that God had entrusted to me. My deep indebtedness was daily evidence of that fact After hearing about dedicating everything I had to God, I went into my bedroom and got down on my knees.

"I pictured everything that I loved and owned behind me—my wife, children, home, car, job, and every other item that I could think of. One by one I pictured myself taking each item from behind me and placing it on God's altar.

"I prayed, 'God, I give You my wife, whom I love. From now on, she belongs to You. If You allow something to happen beyond my control, I will thank You for it. And if You allow me to continue to enjoy her love and fellowship, I will thank You for that. Lord, here is my job. I give You the rights to it. If You continue to allow me to have the job, I will accept the responsibility of working as unto You.'

"I continued praying in this manner until every single item was taken from behind me and placed on the altar. When I finished, I felt an inner freedom that I had never experienced before. That dedication became the turning point in my finances. It released me from the pressure of doing things my way and freed me to learn how to do things God's way.

I WAS ABLE TO TEACH MY CHILDREN TRUTHS THAT HAD BECOME REAL TO ME

"Once I experienced the freedom and blessing of dedicating everything I had to God, I was able to include the family in any new dedication of a possession. One day we bought a camper. I said to my wife and children, 'Let's go out in the camper and dedicate it to God.' We prayed, 'Lord, You gave us the funds for this camper and the direction to buy it. We now give it back to You. You are free to do with it whatever You want. If You allow us to use it, we purpose to use it to bring glory to You.' This time of prayer was especially significant to my young son, and the camper became a means for God to teach valuable lessons to our family."


THE FIRST STEP IS TO RECEIVE JESUS CHRIST AS SAVIOR
